

TARIFF INCREASES FROM 1 JULY 2017 TO CONTINUE TOP SERVICE DELIVERY

The City of Cape Town has tried to balance what is needed to achieve our operational priorities and address the changing needs of our city with consideration of the realities of our residents. For instance, the continuing drought, water scarcity, and the need for additional infrastructure investment to enhance water security, has strongly influenced the water and sanitation tariff increases and those who use excessive water will pay the price.

We have also looked at our financial sustainability and have taken on board National Treasury comments regarding the affordability of continuing to offer free basic services to all residents. This has been amended to ensure that only our most vulnerable residents have access to free basic services.

The great majority of tariff increases for City services are close to or within the inflation range.

Following the public participation process, and the approval of the final Budget for 2017/18, there are some key tariff changes which will be implemented from 1 July 2017:

Water and sanitation tariffs

Due to the pressure on the water and sanitation tariffs, the 2017/18 financial year sees the end of free basic water and sanitation services to all customers. This will now only apply to indigent customers. This is also in line with National Treasury comments for municipalities to reconsider the affordability of providing free basic services to all households.

The non-indigent category will be subject to the phased introduction of payments for the first 6 kℓ for water and 4,2 kℓ for sanitation over the 2017/18 and 2018/19 financial years. The additional impact for the 2017/18 financial year on non-indigent customers will be approximately R27,36 (incl. VAT) per month for water and R18,43 (incl. VAT) per month for sanitation. This charge per kilolitre at the Step 1 tariff is far below the actual cost of delivering water and sanitation.

Electricity tariffs

After extensive public engagement, the City decided to delay the implementation of the proposed Home User Tariff which was discussed during the Budget 2017/18 public participation process. Consumers in properties above the value of R1 million will remain on the Domestic Tariff. Further public engagement about the future implementation of the Home User Tariff will be undertaken at a later stage.

From 1 July 2017 these residential tariffs will apply:

- Lifeline 1 and Lifeline 2
- Domestic Tariff: Lifeline customers with municipal property valuations in excess of R400 000 will be migrated to the Domestic Tariff.

Lifeline Tariff 1: (Purchase less than 250 kWh per month on average + includes 60 free units)

Lifeline Tariff 2: (Purchase between 250 kWh and 450 kWh per month on average + includes 25 free units)

All tariffs are still primarily based on a consumptive charge and thus **the incentive remains for all users to reduce their consumption.**

Also please note that Level 4b restrictions came into effect on 1 July 2017.

TARIEFVERHOOGINGS VANAF 1 JULIE 2017 OM PUIK DIENSLEWERING VOORT TE SIT

Die Stad Kaapstad probeer om 'n balans te behou tussen wat nodig is om ons operasionele prioriteite te behaal en die veranderende behoeftes van ons stad met inagneming van die werklikheid waarin ons inwoners verkeer. Die voortgesette droogte, waterskaarste en die behoefte aan bykomende infrastruktuurinvestering om watersekerheid te bevorder, het 'n groot uitwerking op die verhoging in water- en sanitasietariewe gehad, en diegene wat oormatige water gebruik sal die prys daarvoor betaal.

Ons het ook ons finansiële volhoubaarheid en kommentaar van die nasionale tesourie oor die bekostigbaarheid van voortgesette gratis basiese dienste aan alle inwoners heroorweeg. Dit is gewysig sodat net ons mees weerlose inwoners toegang tot gratis basiese dienste het.

Die oorgrote meerderheid tariefverhogings vir Stadsdienste val naby of binne die inflasiesyfers.

Na die openbaredeelnamesproses en die goedkeuring van die finale begroting vir 2017/18, word sleutelveranderinge in tariewe vanaf 1 Julie 2017 in werking gestel:

Water- en sanitasietariewe

As gevolg van die druk op water- en sanitasietariewe, lui die 2017/18-boekjaar die einde van gratis basiese water- en sanitasiedienste aan alle kliënte in. Dit sal nou slegs op deerniskliënte van toepassing wees. Dit is ook in pas met nasionale tesourie se kommentaar aan munisipaliteite om die bekostigbaarheid van die lewering van gratis basiese dienste aan alle huishoudings te heroorweeg.

Die niedeerniskategorie sal onderworpe wees aan die gefaseerde inwerkingstelling van betalings vir die eerste 6 kℓ water en 4,2 kℓ vir sanitasie oor die 2017/18- en 2018/19-boekjare. Die bykomende impak op niedeerniskliënte vir die 2017/18-boekjaar is ongeveer R27,36 (BTW ingesluit) per maand vir water en R18,43 (BTW ingesluit) per maand vir sanitasie. Hierdie heffing per kiloliter op die stap 1-tarief is baie laer as die werklike koste van lewering van water en sanitasie.

Na uitgebreide openbare skakeling, het die Stad besluit om die inwerkingstelling van die voorgestelde tuisgebruikertarief wat gedurende die openbaredeelnamesproses vir die 2017/18-begroting bespreek is, uit te stel. Verbruikers met eiendomme wat hoër as R1 miljoen gewaardeer is, sal dus op die huishoudelike tarief bly. Verdere openbare skakeling oor die toekomstige inwerkingstelling van die tuisgebruikertarief sal in 'n later stadium plaasvind.

Vanaf 1 Julie 2017 is die volgende residensiële tariewe van toepassing:

- Reddingsboei ("Lifeline") 1 en Reddingsboei 2
- Huishoudelike tarief: Reddingsboeikliënte met munisipale waardasies hoër as R400 000 sal na die huishoudelike tarief oorgeskakel word.

ISixeko saseKapa siye sazama ukulungiselela ngokulinganayo oko kufunekayo ukuze kufezekiswe imibandela yethu ephambili engendlela yokusebenza kwaye sisabele kwiimfuno zotshintsho zesixeko sethu nokuthi sithathele ingqalelo ezona mfuno zabahlali bethu.
