

## ADDENDUM TWO

to the

### MEMORANDUM OF UNDERSTANDING

Between

THE CITY OF CAPE TOWN  
(hereafter referred to as the City)

and

THE CAPE BIRD CLUB  
(hereafter referred to as CBC)

and

BIRDLIFE SOUTH AFRICA  
(hereafter referred to as BLSA)

regarding the

FALSE BAY ECOLOGY PARK (hereafter referred to as FBEP),

and in particular the FALSE BAY PARK IMPORTANT BIRD AREA, SA 116  
(hereafter referred to as the FBP IBA)

Clause 5 of the Memorandum of Understanding (MOU) referred to above, and attached hereto, indicates that the MOU will remain in effect from date of signature till 30 June 2014. It notes that it may be extended or reduced in duration on mutual written agreement.

It is hereby agreed that the MOU, which was extended for a period of 6 months till 31 December 2014, be extended for a further period of 24 months, till 31 December 2016,

In terms of this addendum to the MOU, it is noted that the provisions of the MOU remain valid with the exception of the following aspects:

1. The CBC will no longer being required to appoint a Conservator for the Strandfontein Birding Area (SBA) and provide co-funding for that position, given it has become a City position and a staff member appointed to it on a full-time basis.
2. The CBC will no longer be required to provide labour hours to the SBA.


