## **CITY OF CAPE TOWN**

### **BY-LAW RELATING TO THE REPEAL OF BY-LAWS ADOPTED BY FORMER MUNICIPALITIES, 2025**

**To provide for the repeal of redundant by-laws adopted by former municipalities in the jurisdiction of the City of Cape Town; and to provide for matters incidental thereto.**

**BE IT ENACTED** by the Council of the City of Cape Town, as follows:—

#### **Repeal of By-laws**

1. The by-laws listed in the Schedule, which were adopted by former municipalities, the areas of which were incorporated in the City of Cape Town, are hereby repealed, insofar as they are applicable in the area of jurisdiction of the City of Cape Town.

#### **Short title**

2. This By-law is called the City of Cape Town: By-Law Relating to the Repeal of By-Laws Adopted by Former Municipalities, 2025.

1. Die verordeninge soos in die bylae uiteengesit, wat aangeneem is deur voormalige munisipaliteite waarvan die gebiede in die Stad Kaapstad geïnkorporeer is, word hiermee herroep in die mate dat dit in die Stad Kaapstad se regsgebied van toepassing is.

**Kort titel**
