## CITY OF CAPE TOWN

### CAPE TOWN SUB-COUNCIL AMENDMENT BY-LAW, 2024

To amend the Cape Town Sub-council By-law, 2003 as amended by the Cape Town Sub-Council Further Amendment By-law, 2011 published in Provincial Gazette No 6896 of 5 August 2011, as amended by the Cape Town Sub-council Amendment By-law, 2016 published in Provincial Gazette No. 7698 of 4 November 2016 and as amended by the Cape Town Sub-council Amendment By-law 2022; to disestablish 21 metropolitan sub-councils; to establish 20 metropolitan sub-councils in the area of jurisdiction of the Municipality of Cape Town; to cluster wards for the area of each sub-council; and to provide for matters incidental thereto.

**BE IT ENACTED** by the Council of the City of Cape Town, as follows:—

#### Amendment of section 1 of the Cape Town Sub-council By-law, 2003

1. Section 1 of the Cape Town Sub-council By-law, 2003 is amended by the substitution for the definition of "City Manager" of the following definition:

"**City Manager**" means the municipal manager referred to in section **[82 of the Structures Act]** 54A of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000) and who has been appointed as the City Manager;"

#### Substitution of section 2 of the Cape Town Sub-council By-law, 2003

2. The following section is hereby substituted for section 2 of the Cape Town Sub-council By-law 2003:

#### "2. DISESTABLISHMENT

With effect from midnight on the day before the effective date the twenty-one sub-councils set out in column 1 of Schedule 1 and consisting of the cluster of wards set out in column 2 of Schedule 1 shall be disestablished"

#### Substitution of section 3 of the Cape Town Sub-council By-law, 2003

3. The following section is hereby substituted for section 3 of the Cape Town Sub-council By-law, 2003:

### **“3. ESTABLISHMENT**

With effect from the effective date, the twenty sub-councils set out in column 1 of Schedule 2, shall be established for the area consisting of the cluster of adjoining wards set out in column 2 of Schedule 2.”

#### **Substitution of section 5 of the Cape Town Sub-council By-law, 2003**

4. The following section is hereby substituted for section 5 of the Cape Town Sub-council By-law 2003:

### **“5. COMPOSITION**

(1) A sub-council is composed of:

(a) the elected ward councillors of wards contained in the sub-council, and

(b) the proportional councillors allocated to a sub-council in terms of Section 63(1) **[of the Structures Act read with Section 62(cA)(where applicable)]** and Schedule 4 of the Structures Act.

**[(2) The mechanism referred to in Section 62(cA) for the appointment of councillors to sub-councils shall be as follows:**

**The speaker, after consultation with the chief whips of the parties represented in council will recommend to council the allocation of the Section 63(1)(b) seats to the parties in a manner that reasonably reflects the governing majority in council.]”**

#### **Substitution of Schedules 1 and 2 of the Cape Town Sub-council By-law, 2003**

5. Schedules 1 and 2 of the Cape Town Sub-council By-law, 2003 are hereby substituted by Schedules 1 and 2, respectively, as set out in the Annexure to this By-law.

### **SHORT TITLE**

6. This By-law is called the Cape Town Sub-council Amendment By-law, 2024.

### WYSIGINGSVERORDENING OP KAAPSTAD-SUBRADE, 2024

Om die Verordening op Kaapstad-subrade, 2003, soos gewysig deur die Verdere Wysigingswet op Kaapstad-subrade, 2011, gepubliseer in Proviniale Koerant no. 6896 van 5 Augustus 2011, soos gewysig deur die Wysigingsverordening op Kaapstad-subrade, 2016, gepubliseer in Proviniale Koerant no. 7698 van 4 November 2016 en soos gewysig deur die Wysigingsverordening op Kaapstad-subrade, 2022 te wysig; om 21 metropolitaanse subrade te ontbind; om 20 metropolitaanse subrade in die regsgebied van die Munisipaliteit van Kaapstad in te stel; om wyke vir die gebied van elke subraad saam te groepeer; en om voorsiening te maak vir aangeleenthede wat daarmee verband hou.

#### Wysiging van artikel 1 van die Verordening op Kaapstad-subrade, 2003

1. Artikel 1 van die Verordening op Kaapstad-subrade, 2003 word hiermee gewysig deur die omskrywing van "stadsbestuurder" met die volgende omskrywing te vervang:

"**stadsbestuurder**" die munisipale bestuurder ooreenkomstig artikel **[82 van die Wet op Strukture]** 54A van die Wet op Plaaslike Regering: Munisipale Stelsels, 2000 (Wet 32 van 2000) en wat as Stadsbestuurder aangestel is;"

#### Vervanging van artikel 2 van die Verordening op Kaapstad-subrade, 2003

2. Artikel 2 van die Verordening op Kaapstad-subrade, 2003 word hiermee met die volgende artikel vervang:

#### "2. ONTBINDING

Met ingang van middernag op die dag voor die effektiewe datum word die een-en-twintig subrade soos uiteengesit in kolom 1 van skedule 1 en bestaande uit die groep wyke soos uiteengesit in kolom 2 van skedule 1, ontbind."

#### Vervanging van artikel 3 van die Verordening op Kaapstad-subrade, 2003

3. Artikel 3 van die Verordening op Kaapstad-subrade, 2003 word hiermee met die volgende artikel vervang:

### **“3. INSTELLING**

Met ingang van die effektiewe datum word die twintig subrade soos uiteengesit in kolom 1 van skedule 2 en bestaande uit die groep aangrensende wyke soos uiteengesit in kolom 2 van skedule 2, ingestel.”

#### **Vervanging van artikel 5 van die Verordening op Kaapstad-subrade, 2003**

4. Artikel 5 van die Verordening op Kaapstad-subrade, 2003 word hiermee met die volgende artikel vervang:

### **“5. SAMESTELLING**

(1) 'n Subraad bestaan uit:

(a) die verkose wyksraadslede van die wyke vervat in die subraad, en  
(b) die raadslede wat proporsioneel aan 'n subraad toegeken is ingevolge artikel 63(1) [**van die Wet op Strukture saamgelees met artikel 62(cA) (waar toepaslik)**] en Bylae 4 van die Wet op Strukture.

**[(2) Die meganisme met betrekking tot artikel 62(cA) vir die aanstelling van raadslede op subrade is as volg:**

**Die speaker, na oorlegpleging met die hoofswepe van die partye wat in die raad verteenwoordig is, beveel by die raad die toekenning van die artikel 63(1)(b)-setels aan die partye aan op 'n wyse wat die regerende meerderheid in die raad weerspieël.]”**

#### **Vervanging van bylae 1 en 2 van die Verordening op Kaapstad-stadsrade, 2003**

5. Bylae 1 en 2 van die Verordening op Kaapstad-subrade, 2003 word hiermee vervang met onderskeidelik skedule 1 en 2, soos uiteengesit in die bylae wat by hierdie Verordening aangeheg is.
