The focus remains to secure broadcasted, hybrid and virtual events as well. It should be noted that the ongoing engagement with the Events/Film Industry and the easing of the lockdown regulations in South Africa amidst the COVID 19 pandemic has contributed to the success of CTS's performance to date.

Due to the uncertainty at the time of the budget approval around the changing COVID-19 regulations, the entity followed a conservative approach and did not include the BIL tour in the budget.  In addition, the entity hosted five (5) non-bowl events and 1 film shoot. The entity also earned income from the DHL naming rights agreement as well as the rights fees received from the vendors as negotiated in their contract. The income earned from this income was initially budgeted for the previous financial period, however due to a delay, the naming rights contract with DHL Express was only approved in July 2021 and income only realized in the quarter under review.
