#### **Host Organisation – West Desert Antarctica:**

White Desert operates high end tourism offereings from Cape Town to Antarctica. Travellers have the choice between their Greatest One Day or Week Stay offerings.

#### **Host Continent – Antarctica:**

The continent of Antarctica is the fifth-largest, southernmost and least-populated land mass on earth. The continent is divided into West and East Antarctica, and is separated by the Transantarctic Mountains. Antarctica is a polar desert, and receives minimal rainfall of about 150mm per year, predominantly in the form of snow. Most of the area is therefore covered by an Antarctic ice sheet that is approximately 1.9 km thick. It is estimated that the ice sheet holds 70 per cent of the world's freshwater reserves. The lowest recorded temperatures on earth of around (minus) 85 degrees centigrade have been recorded in Antarctica, however the coastal regions can reach 10 degrees in summer. The continent is therefore colder than the Arctic region, and this is due to the continent being 3 000 metres above sea level, where air temperatures are colder.

Antarctica does not have a sovereign government and is instead governed by a set of international agreements. The principle agreement is the Antarctic Treaty System which came into force in 1959, with South Africa becoming a signatory in 1961. The Treaty provides a framework for peaceful cooperation and exploration of the continent, while also promoting scientific cooperation and prohibiting mining and military conflicts. Essentially, Antarctica is meant to be a continent reserved for peace and science. Currently, 55 countries form part of the Treaty with 29 of these having the right to participate in decision making through its secretariat. Approximately 30 countries have an estimated 80 research bases, some of which are only open in the summer months, while others are operated for the entire year. It is estimated that 5 000 people reside at research stations during summer. It is worth mentioning that no territorial claims made by any country has been recognised in Antarctica. Lastly, besides research, tourism and fishing are also popular activities.



## 4. OBJECTIVE

To promote Cape Town as a gateway to Antarctica, and encourage direct air access, coupled with responsible tourism.

Gained insights and best practices regarding responsible tourism, and how to tap into this fairly new tourism offering.

- 6.3 Facilitate interactions to address red tape issues for private sector stakeholders such as WDA (Responsible: Enterprise & Investment Department)

#### **GENERAL DISCUSSION** 9.


