#### **PROVIDE SUMMARY OF HOST ORGANISATION**

The event is organised by the Guangzhou International Award for Urban Innovation in partnership with the Guangzhou Municipality. It aims to promote exchanges between international cities and regional governments on urban governance innovation, to further implement the United Nation Sustainable Development Goals (SDGs) and the New Urban Agenda (NUA), and encourage global cities to participate in global governance, so as to contribute their wisdom to a more equitable and coordinated system of global governance. It convenes the forum in partnership with Metropolis, United Cities and Local Governments, Chinese People's Association for Friendship with Foreign Countries and Global Mayors Forum.

## 4. OBJECTIVE

The City of Cape Town's Food Systems Programme was one of 15 shortlisted submissions to the prestigious Guangzhou International Award for Urban Innovation (the Guangzhou Award). The objective of the trip was therefore to attend the awards ceremony on Thursday, 7 December followed by the Global Mayor's Forum on Friday 8 December and Saturday 9 December 2023. The organisers invited Ms. Faragher and Cllr Carls (who represented the Mayor) to attend these events.

The reason for attending was to (1) attend the awards ceremony; (2) deliver a keynote at the Global Mayor's Forum convening; and (3) participate in a media briefing with Cllr Carls.

The Food Systems Programme was awarded a Medal of Honour, in addition to a Scholarship Certificate for IDE Programme. The details of the latter are unknown at this time, clarification regarding the scholarship is awaited.

# 5. OUTCOMES

Participation enhanced the City's global profile as a global leader in innovation and food systems and the media briefing expanded the City's audience beyond the events.

Exposure to other ideas and connections to cities offers opportunities to deepen our practice in areas such as wastewater management in informal settlements and informal trade management.

Further knowledge exchanges are planned, but details are not available at this time.

The Scholarship Certificate is for one student to attend the International Design Education (IDE) Programme. It is a cooperation programme between the United Nations Technology Bank for the Least Developed Countries (UN Technology Bank), the World Eco-Design Conference (WEDC) and Zhejiang University, Ningbo (ZJUNB). It was launched in 2021 and is funded by ZJUNB. The postgraduate programme is 2.5 years and is open to 50 eligible students each year. The student who successfully completes the Programme will be conferred with a Master's degree in Industrial Design Engineering.

The application guide for the next intake of the IDE Programme is expected to be issued next month (February, 2024).

## 9. GENERAL DISCUSSION

The Food Systems Programme work was awarded a Medal of Honour at the awards. Site visits to a dried food market and canal rehabilitation project were arranged at Ms. Faragher's request. Even though Chinese culture and practice differs to South Africa's, there were nevertheless similarities and learnings.

The canal project illustrated similar approaches to stormwater management and challenges, but also illustrated success in ecological restoration in highly urban areas. The market visit highlighted the important role of municipal-run markets and their local and international economic potential.

The combination of awards and forum events such as the Pearl River Cruise and visit to the Waste Centre provided opportunities to learn about how other cities are approaching SDG goals and challenges, as well as witness cutting edge technology within a mega-city context.
