PROVIDE SUMMARY OF HOST ORGANISATION / CITY

DTU Technical University of Denmark is one of Denmark's foremost institutions of higher learning. It was the host university where both the Energy Efficiency and Energy Management in Buildings and Industry Programme as well as the Physical and Financial Power Markets Programme both of which were under the Danida Fellowship Centre (DFC) scholarship was held. On behalf of the Ministry of Foreign Affairs, Danida Fellowship Centre administers the development research grants provided by Denmark's development cooperation, Danida (https://dfcentre.com/organisation/).

The DFC programme builds on the understanding that individuals matter; and with the right knowledge, competencies and motivation, individuals can become key change makers in their organization. DTU offered an ideal platform with its strong emphasis on sustainability and cutting-edge solutions in energy systems for the two professional courses attended on energy efficiency and power markets.

The university's interdisciplinary approach, combined with its expertise in both energy technology and economics, has supported:

- The development of practical solutions for reducing energy consumption and promoting sustainable practices in industrial and building sectors, making it a key contributor to global sustainable development goals.
- Policy insights, technical innovations and the supply of graduates to start-ups and regulatory organisations to support the development and functioning of power markets in Denmark and across the world, enabling the more rapid uptake of low carbon generation technologies.

4. OBJECTIVE

Attending the Energy Efficiency in Buildings and Industry course provided an in-depth understanding of cutting-edge technologies, strategies, and best practices for

reducing energy consumption and improving efficiency in both buildings and industrial operations. The course covered the importance of energy efficiency and energy management as a part of a national energy transition, implementing an energy management scheme in an industry or a building organization, developing a business case for implementing energy saving measures in an industry or building organization, methods to assess and monitor energy use, the development of a maintenance and operation plan, as well as relevant technologies and concepts for improving energy efficiency. By gaining practical insights and learning from case studies, the attendee is now equipped to assess current energy use in the City and identify opportunities for improving efficiency, reducing operational costs, and lowering carbon emissions.

One of the foremost challenges is the need to manage energy usage at wastewater facilities which presents challenges that involves navigating various complexities. By gaining expertise in energy management systems, it has equipped me with the knowledge and skills to assess the feasibility of various energy efficiency projects and drive their implementation within waste water treatment plants.

Attending the Physical and Financial power markets course funded by the Danida Fellowship Centre and Hosted by DTU provided the attendees with insightful knowledge on the benefits, concerns and characteristics of Energy and Power Markets. This is especially relevant to South Africa where legislation has established an electricity market operator in the National Transmission Power Company of SA which has announced that it will launch a physical power market exchange as soon as April 2026. This will mean that municipal distributors (such as the City of Cape Town's) will face difficult changes as participation in the new market will entail new risks and responsibilities as well as unbundling into Distribution System Operators and Electricity Retailers.. Through attendance of this course we will now be better positioned to support the City of Cape Town during this transition, transferring critical information and international perspectives.

5. OUTCOMES

Enhanced energy efficiency initiatives, reduction in carbon emissions, cost savings for the City, capacity building and knowledge sharing, strengthened policy framework and resilience and sustainability.

An improved understanding of physical and financial power markets in order to better support the City's Energy Directorate to participate in the wholesale electricity market in the future and manage the risks. Furthermore, the knowledge acquired on feasibility studies and physical power markets will provide critical insight into future investment decisions when considering new innovative projects in the Sustainable Energy Markets department.

Participate in a follow-up online meeting scheduled three months after the course to discuss the key outcomes, actions taken, changes implemented, and overall progress since the program.
