PROVIDE SUMMARY OF HOST ORGANISATION / CITY

The Danida Fellowship Centre (DFC) offers learning opportunities to Denmark's partners in developing and growth countries prioritized by Denmark's development cooperation. DFC cooperates closely with the Ministry of Foreign Affairs of Denmark who is responsible for the political and strategic aspects of the development research grants, and defines the framework for the capacity development activities undertaken by the DFC.

NIRAS was selected on behalf of DFC as the facilitators and coordinators of the learning programme attended by the official. NIRAS is located in Denmark and is a multi-disciplinary engineering consultancy dedicated to sustainable progress and service delivery, aiming to contribute greatly to meeting the Sustainable Development Goals.

4. OBJECTIVE

The City of Cape Town is currently in the implementation phase of the recently approved Climate Change Strategy and Climate Change Action Plan (CCAP). Attendance of this learning programme assisted the City's climate change planning team in learning and interacting with new and innovative thinking, practices, tools and technologies as it relates to international climate change response relevant to the City of Cape Town.

Technical mentorship received during the course, guided the drafting of an Action Plan aimed to increase overall participation, awareness and education of internal departments and external stakeholder including the public. The course also presented an opportunity to discuss and share innovative practices as it relates to the implementation and development of the City's own climate change response.

5. OUTCOMES

In addition to knowledge sharing and networking opportunities with participants from other developing countries and Denmark, the main output from the learning programme was the development of an Action Plan through the support and guidance of a mentor who is a chief consultant at NIRAS specialising in environmental risks, water, energy and climate change.

The Action Plan focussed on supporting the implementation of the City's Climate Change Strategy and Action Plan (CCAP) and was discussed internally by the City's climate change planning team before the training in Denmark commenced. The Action Plan is structured around increasing participation, awareness and education as it relates to climate action and focusses on external stakeholders and internal departments leading implementation of the CCAP.

6. ACTIONS REQUIRED

- Further development and finalisation of the Action Plan developed in Denmark
- Continued engagement through consultancy based support from NIRAS and DFC until April 2023 to complete and implement the Action Plan
- Submit an Action Plan Status Report to NIRAS and DFC after April 2023

9. GENERAL DISCUSSION

The Danida Fellowship Centre (DFC) located in Denmark, recognizes the urgency of global climate response and action by supporting sustainable development and equal opportunities through capacity development, learning programmes, collaborative research projects, networking and knowledge sharing across various countries worldwide including South Africa.

The City of Cape Town is currently in the implementation phase of the recently approved Climate Change Strategy and Climate Change Action Plan (CCAP). The documents apply a framework that integrates both mitigation and adaptation across internal departments, prioritize stakeholder engagement and collaboration, and learning and sharing of knowledge on a local, national and international scale.

The integrated component of the course presented an opportunity to form new perspectives and insights into approaches and challenges around the implementation of the various actions and processes in the CCAP. Attendance of this course contributed meaningfully to the professional development of the official attending as part of the team leading the overall coordination of the City's climate change response.

The Action Plan development component of the course, aims to potentially address the challenges below to increase awareness, education and participation in climate change action internally and amongst external stakeholders.

- Implementing the inclusionary actions of the CCAP in a socioeconomic context in which climate change is not a priority for most households.
- Articulating co-benefits to promote buy-in from City departments as well as the private sector.
- Supporting and facilitating mainstreaming within City departments and the private sector that motivates increased uptake of responsibility for addressing climate change adaptation and mitigation.
