#### PROVIDE SUMMARY OF HOST ORGANISATION / CITY

The host organisation, Danida Fellowship Centre (DFC), co-operates closely with the Ministry of Foreign Affairs of Denmark to offer learning opportunities. The opportunities are offered to partners in Danida financed development cooperation projects and programmes in developing and growth countries.

The current strategy of DFC is *Knowledge in Action 2021 – 25*. It promotes knowledge uptake and impact especially by employing engagement and communications skills as the driver to bring knowledge into action.

The DFC Scholarship Programme builds on the understanding that individuals matter; and that with the right knowledge, competencies and motivation, individuals can become key change makers in their organization. The scholarship programme offers opportunities for continued education and learning developed and implemented through a highly organic process, where dialogue, collaboration, flexibility and creativity is at the centre, and where learning programmes offered have a strong focus on usability and applicability.

#### 4. OBJECTIVE

The DFC Scholarship learning programme requires participants to travel to Denmark and attend in person to exchange of knowledge, expertise and learnings and complete their learning programme. There are no telephone or video conferencing facilities available for these specific learning programmes. Part of this learning programme is to participate in site visits and classroom exercises.

Ms Fadzai Kadzinga; Assistant Professional Officer within the Data Management & Integration Platform branch, SEM department role is to support development of energy and financial models. These models' purpose is to guide the City in achieving its carbon goals while providing access to energy to Cape Town citizens.

Ms Kadzinga is part of a team where they use Low Emissions Analysis Platform (LEAP) to model various aspects of the City's energy system. Exploring different scenarios using LEAP in a context different from her everyday job and the course enhanced her knowledge of the tool and broadened the ways in which she can approach the department's energy systems modelling and planning.

Mr Bashkaran Vandeyar is the Head of Green Energy, within SEM department, and central to his core job function is energy planning. Working with several commitments to greenhouse gas and emissions reduction, there is a tremendous need to plan and forecast what is financially and technically viable.

Technical skills such as energy modelling are critical and scarce within the organisation, and Mr Vandeyar is in a position to lead and share this knowledge within his department (SEM) as well as put it to practical use.

The Energy Planning course expanded Ms Kadzinga's and Mr Vandeyar's understanding of electricity markets and the economic, environmental, regulatory and financing concerns associated with energy systems. This

knowledge will be useful in understanding any local energy markets which are likely to develop in the near future.

Attending the course contributes to improvement of the City's capacity in Energy modelling and planning and is a (very small) step towards us continuing to fulfil our obligations to the citizens

## 5. OUTCOMES

Participants attended the course and had the opportunity to understand how energy markets evolve and operate in developed countries as well as getting insight into how other developing countries are moving toward an open energy market landscape.

Participants improved their understanding of evaluating social impact, the boundaries scope, reserve power markets, modelling energy systems in LEAP as well as interpretation of results.

There were several excursions to modern facilities for wind turbine testing, thermal heat storage and district heat and a large scale waste to energy plant – all facilities that are not available in South Africa and provided a different perspective on heat recovery and waste management.
