#### PROVIDE SUMMARY OF HOST ORGANISATION / CITY

The Fast-Track Cities initiative is a global partnership between cities and municipalities around the world and four core partners – the International Association of Providers of AIDS Care (IAPAC), the Joint United Nations Programme on HIV/AIDS (UNAIDS), the United Nations Human Settlements Programme (UN-Habitat), and the City of Paris.

Mayors and other city/municipal officials are encouraged to designate their cities as Fast-Track Cities by signing the Paris Declaration on Fast-Track Cities, which outlines a set of commitments to achieve the initiative's objectives. Initially heavily focused on the 90-90-90 targets, the Paris Declaration was recently updated to establish attainment of the three 90 targets as the starting point on a trajectory towards getting to zero new HIV infections and zero AIDS-related deaths.

#### 4. OBJECTIVE

This event brought together delegates from over 500 Fast Track Cities across a global network of cities.

## Objectives included:

$\square$ To support cities and municipalities worldwide to accelerate their responses
to HIV, TB, viral hepatitis, and other health conditions in support of
healthy, equitable, and resilient communities, through sharing of best
practice and innovative approaches

☐ To leverage networks of expertise to accelerate learning to prevent and treat HIV, TB and viral hepatitis within City context.

☐ To sustain momentum generated for and re-double the political and societal commitment necessary to achieve all health-related Sustainable Development Goals (SGDS) by 2030.				
OUTCOMES				
Technical learning: City officials attending the conference participated in a one day programme of skill-building sessions. In particular the session on Practices to Enhance Equity offered a novel approach, considering the recognitional, participatory resource, structural and intergenerational aspects of equity which will add to our conceptualisation of how the institutional capabilities of a City setting can assist in eradicating HIV and TB.				
City officials learnt about technical ways to assess equity in the scaling up of the Pre-exposure Prophyllaxis (PreP) service				
Feedback on the proposed Framework for Health Equity Action: The proposed COCT Framework for Health Equity Action was presented in an oral presentation which allowed peer review and received peer endorsement. This led to requests for further information regarding our proposed approach.				
Networking and connection building: City officials met with peers from other cities who are participating in 500 Fast Track Cities and shared lessons learnt. Of note, we engaged the deputy City Manager and team from eThikweni, and learnt about their experience of being a Fast Track City since inception 10 years ago. City Officials had a side meeting with Professor Brian van Wyk of School of Public Health, University of the Western Cape, who expressed interest in supporting City Health through an academic partnership.
