<p>The free state of Bavaria, the province of the Western Cape and the Hannes Seidel Foundation have a longstanding partnership focused on promoting human security. Out of the partnership, a close cooperation between the Western Cape Government (WCG), the City of Cape Town (CoCT), the Institute for Security Studies (ISS), and the Bavarian State Police (BSP) has been forged. Together, these parties have initiated a joint project to assist law enforcement agencies in reducing violent crime using data-led and evidence-based police practices.</p>


