Cape Town was selected to be part of the 100 Resilient Cities (100RC), pioneered by the Rockefeller Foundation, in May 2016. This network comprises 100 cities from across the world that are each committed to building city resilience around the social, economic and physical challenges of the 21st century.

Through membership of the 100RC network a challenge was issued by a partner organization, called Colu Technologies, for participation in a workshop assessing the viability of running a pilot programme. Colu helps cities catalyse urban resilience with local based coins/rewards. With this technology Cities are able to create and adopt their own coins as a tool for economic growth and resilience.

A citywide rewards platform would allow stakeholders to incentivize residents for impactful and positive behaviour, from stimulating local spending, through to sustainable living and social inclusion.

4. OBJECTIVE

Participation in the workshop provided exposure to expert training, knowledge sharing from Cities who have a City currency and insights into what stage of readiness is required to begin designing and evaluating a prototype.

Given the scale of Cape Town's unemployment problem, need for socioeconomic reform and spatially segregated spending patterns it would be hugely beneficial for the City to start evaluating technology-driven solutions that could form the basis of targeted, scalable interventions.

9. GENERAL DISCUSSION

The following learnings from the workshop are worth noting:

 The City Currency/Coin (CC) was originally intended to be issued as a cryptocurrency on the Blockchain. Due to the limitation of the technology as well as the regulatory hurdles posed by this approach, the current methodology is to provide a platform-based application.

- Belfast is planning on using the CC to incentivize spending around an area that has limited access due to a recent fire of the Primark historical building in the center of their CBD. The proposed deadline for launch is August 2019.
- Michael Eisenberg, the chief investor in Colu technologies, gave a talk that hypothesized most trust mechanisms will in the future, assisted by technology, devolve to an interpersonal level. He believes that economic power lies with Cities and a more conscious effort be made by them to enable and empower citizens to take ownership and action around sticky social issues.
- Colu provides a high level of flexibility to incentivize areas or priorities for City goals and priorities, examples of themes that can be packaged include living local, health, farm to table, mobility, kids and family and pay it forward. Each theme can then be linked to merchants or programmes in a specific area. This is an advantage of a technology based solution.
- The traceability and impact of each intervention and related reward can be tracked and measured - allowing a high level of accountability regarding the incentive spend. There is a large gap in the City's ability to understand economic activity at a neighborhood level, and the opportunity to generate this data through a pilot should be seriously considered.
- Regarding the mechanics of the transacting, Colu would need to set up a local bank account and operation to operate in an area, and this may be facilitated through an existing financial service provider.
- Users currently load money into their wallet using credit cards, and merchants require bank accounts to receive payment. Both users must have apps on their phones, and access to data. There is flexibility in adapting this to the market in question.
- The City has 2 roles the first to define the priority areas and themes that enhance citizen wellbeing, and the second, is to fund the incentive and reward citizens for participating in goals. The latter requires the City to deposit funds to be managed and distributed by Colu according to the terms agreed to, for example a reward may be 10 CC for taking 5 bus rides or 15 CC for volunteering for 2 hours etc.
- There has to be a verifiable handshake event (i.e. be able to verify the behavior has occurred) in order for the reward to be paid this can be

integrated with other APIs where possible, or can be done manually via a spreadsheet.

- Users at the moment don't swap wallet or CC funds person to person, however they can donate to a common cause. This functionality may be developed if required
- Employers may have CSI funds or reward schemes that they currently
 offer to their employees this is an opportunity to crowd in impact and
 align. It also provides a potential immediate large scale user base,
 along with University students
