PROVIDE SUMMARY OF HOST ORGANISATION / CITY

International Training Center for International Labour Organisation (ITCILO) is the training institution for the ILO. It is responsible for offering training, learning and capacity development to ILO members' states, South Africa being a member. This is a highest international labour law Training center, which promotes decent work through social dialogue.

4. OBJECTIVE

The trip was a result of an invitation through the SALGBC. I am a member of the National Bargaining Committee member of the SALGBC, which is currently ceased to negotiate amongst others, the Main Collective Agreement; the Wage Curve; the Compensatory Framework. I am also a member of a team tasked to facilitate a cluster to conduct a research in preparation for the upcoming

National Wage Negotiation (I will be a member of the negotiating team). Due to my responsibility as Employee Relations Manager, Locally I am the lead negotiator for the City at the Cape Metro Divisional Council and am responsible to oversee all labour and employment related matters within the City. Since my key role includes influencing the decisions of stakeholders including the SALGA decision, the Course was relevant and has add significant value to the strategic plans of the City.

Having acquired the practical skills on various forms of social dialogue, I will apply this on my day to day duties first in my capacity as Manager responsible for employee relations and secondly as a both local and central collective bargaining negotiator.

In the next three months, starting with the local level, I will introduce a social dialogue strategy to covers all forms of social dialogues from information sharing to collective bargaining. I will motivate for a basic training for our social partners at the local level to prevent and resolve disputes through social dialogue.

At the central bargaining, I am fortunate that all three social partners in our bipartite relationship attended this this course. I will play my role to influence employers to respect and observe the importance of social dialogue.

5. OUTCOMES

Having completed all activities which included face to face engagements in Turin, pre and post course written assessments. I now qualify to receive a certificate of participation. I shall also qualify to receive a certificate of achievement should I complete an optional assignment.

I am required to complete all pre and post course written assessments which were due on 31 January 2024. I have already successfully completed these. I now await certificate.
