<b>PROVIDE SUMMARY OF HOST ORGANISATION / CITY</b>	
<p>South Africa through our National Federation of Netball South Africa has bid to host the Netball World Cup 2023 in Cape Town to the International Netball Federation (INF). As part of the bidding process the two countries (South Africa and New Zealand) bidding for the event were required to present their bid in Singapore on 26 November 2018.</p> <p>The Netball World Cup has never been hosted on the African continent. The sport has seen significant growth in South Africa and Africa and the opportunity to host the Netball World Cup would attract more participants, investment and raise the profile of the sport. It was therefore imperative for all spheres of government to participate in the bid presentation to showcase its commitment. If this bid is successful it will assist in:</p> <ul style="list-style-type: none"> <li>• inspiring and developing the next generation of netball players in South Africa and Africa;</li> <li>• promoting women in sport;</li> <li>• changing the perceptions of women's sport;</li> <li>• enabling netball fans from SA, Africa and the world to experience the excitement of seeing the world's best netballers in action; and</li> <li>• showcasing Cape Town's commitment to empowering women and women's sport.</li> </ul>	

#### 4. OBJECTIVE

The purpose of the trip to Singapore was to form part of the South African delegation who presented the bid to the INF to host the Netball World Cup 2023 in Cape Town, South Africa. The delegation was made up of the following individuals:

On arrival in Singapore on 24 November 2018 the bidding team met to:

- review the bid presentation and the questions and answers document; and
- agreed on the strategic approach to the bid presentation as well as who would be covering which section of the presentation.

On 25 November 2018 the bidding team met to:

- do a dry-run of the presentation;



- finalise each presenter's script;
- work on the timings and technical aspects for the presentation; and
- work on the questions and answers document which needed to be submitted to the bid evaluation committee on 26 November.

On 26 November 2018 the bidding team met to:

- final dry-run with the Minister;
- present South Africa's bid to the bid evaluation committee; and
- have a debrief on the presentation.

The trip assisted in building relationships between the City, Western Cape Government, National Government and Netball SA. It has also assisted the City's Events Department in better understanding the bidding protocols and processes. This processes has also assisted in gaining experience and knowledging in preparing as well as presenting a bid. It has also provided the team with insight on National Government's approach to bids and future plans in terms of bidding for events.

## 5. OUTCOMES

The bid presentation was well received by the bid evaluation committee. The only major concern raised during the presentation was the financials, as the bid evaluation criteria stipulated that the minimum profit had to be £1 million GDB. The South African delegation, however committed to ensuring that the minimum amount was met. Following the presentation, the Western Cape Government increased their commitment to the bid and the City of Cape Town committed to reviewing its commitment to assist if bid.

The International Netball Federation will decide by March 2019 and award the bid to the successful host country. If South Africa's bid is successful a Host Agreement will be signed with Netball South Africa.
