3. EVENT SUMMARY

The purpose of the trip to Seoul, South Korea was to participate in the Knowledge Sharing Programme, which focuses on exchanging Korea's development experiences and expertise. The delegation included the Mayoral Committee Member for Economic Growth, Alderman James Vos, along with City officials from the Economic Development and Investment Department, Property Development, Policy and Strategy, and representatives from the Atlantis Special Economic Zone (ASEZ). The visit was organised through invitations from the Korea Trade and Investment Agency (KOTRA), the Economic Ministry, and Korea Management Association Consulting (KMAC). This Programme provides technical assistance, policy advice, and capacity-building support to promote sustainable development and economic growth in partner countries.

This report assesses the outcomes of the engagements in South Korea from 13 to 20 July 2024. The visit aimed to gain insights from Korea's expertise and enhance the City's strategies in economic development and the ASEZ. This follows on previous visits from Korean delegates during March and May 2024 where relevant collaborative research was conducted and a first draft of the report was delivered.

The trip presented a critical opportunity to explore and enhance economic partnerships and collaborations as well as learnings from industrial policies and strategies. By engaging with South Korea's special economic zones and leading businesses, the delegation aimed to achieve significant outcomes in several key areas:

- 1. Economic Growth: Gain insight into South Korea's strategies for managing special economic zones to attract investment and foster economic growth.
- 2. Strategic Partnerships: Establish relationships with key South Korean businesses and stakeholders, facilitating joint ventures, technology transfers, and collaborative projects.
- 3. Innovative Strategies: Acquired knowledge about innovative approaches to sustainable development and carbon neutrality, which could be applied to the City's economic initiatives.

The implementation of the Knowledge Sharing Programme holds the potential to learn from Korea's world-leading approach to economic development and industrial development and in doing so to significantly streamline and enhance investment processes within Cape Town and ASEZ. By fostering an environment conducive to investment, the program facilitates the flow of capital into key sectors, particularly those aligned with sustainable development goals. The program itinerary covered visits to various to smart cities. Resource recovery facilities, free economic zones and industrial cluster agencies.

PROVIDE SUMMARY OF HOST ORGANISATION / CITY

In 2020, the Korea Trade and Investment Agency (KOTRA) invited the City of Cape Town to apply for their Knowledge Sharing Programme (KSP). In 2022, the City's Economic Analysis branch (part in the Policy and Strategy Department) and Economic Development and Investment Department (then referred to as the Enterprise and Investment Department), submitted a successful proposal on the topic of 'Aligning Greener Production in the Atlantis SEZ with the City's Carbon Neutrality Goals'.

The project commenced in March 2024 when the City hosted delegates from South Korea in the City hall. Since then, members of Korea Management Association Consulting (KMAC) – the delivery team, visited again in May 2024 to visit the SEZ and to meet with various stakeholders. The City collected and gathered information as inputs towards a report completed by KMAC. The KMAC research team presented a draft version of the report during their visit in May 2024. A second version of the research report was presented by KMAC during the trip.

On both occasions, the City organised meetings with key stakeholders including the Atlantis SEZ, officials from the Economic Development and Investment Department, SEM officials, SPVs (Greencape), Wesgro, national departments and relevant businesses.

Host organisations:

KOTRA is South Korea's national trade and foreign investment promotion agency. It was established in 1962 to develop Korean economy and boost country/city relationships to share knowledge and expertise. KOTRA forms the link between the City of Cape Town and KMAC.

KMAC is the research team. This is a comprehensive consulting company that provides differentiated knowledge by converging the five areas of diagnostic evaluation, consulting, education, research and media. KMAC have been leading countries, industries and companies by providing solutions through their research methodologies. The company expands and improves its unique differentiation accumulated through years of project experience and converges internal and external capabilities.

KMAC continuously expand to new areas of innovation, create added value through databased platforms, experts and networks to strengthen national and industrial competitiveness. Its approach to create value provides opportunities for growth to all customers in a rapid changing environment. With the effort of giving the best to their customers, we promise to secure their status as an Innovative Knowledge Platformer representing Asia beyond Korea.

4. OBJECTIVE

The purpose of the sponsored trip to South Korea was to participate in the **capacity building and training program** hosted by KMAC and KOTRA. This capacity building

program is the third phase of the broader Knowledge Sharing Program (KSP). On the City's side the KSP's key participants are the Economic Growth Directorate and the Atlantis Special Economic Zone supported by the Future Planning and Resilience Directorate (through its Policy and Strategy Department). The City's key objectives in participating in the KSP are as follows: Identifying and implementing strategies to enhance investment conditions, facilitating the transition towards carbon neutrality, and fostering the growth of green industries within the ASEZ with the aim of optimizing economic, environmental and social outcomes, all through drawing upon South Korea's experience in developing special economic zones. While much insight had already been gained through engagement with the Korean KMAC team, who had made two visits to Cape Town, and had presented a first draft report, the visit to South Korea to see, firsthand how they implement these policies within their own economic zones was deemed essential to the building of the capacity of Cape Town officials to replicate the Korean successes.

5. OUTCOMES

The trip to South Korea undertaken by representatives of the Property Development; Economic Development and Investment; Policy and Strategy; Mayoral Committee team and ASEZ between the 13th and 20th July was a highly informative and educational experience, providing the team with insights that can be transferred to the Cape Town context to enhance economic development in the City. In addition to the insights gleaned from a range of site visits and meetings with economic development practitioners; companies; economic zones and municipal entities, the trip afforded the City of Cape Town the opportunity to develop relationships and potentially establish partnerships with a range of Korean institutions and companies.

This collaboration, facilitated by representatives from various departments including ASEZ, the Economic Development and Investment Department, the Economic Growth Directorate, and the Policy and Strategy Department, underscores the city's commitment to leveraging its status for mutual economic growth and cultural exchange opportunities.

The following are the value-adds to the City of Cape Town and ASEZ emerging from this trip:

- The learnings obtained from the visit to South Korea, the contacts made and material received, will be used by both ASEZ and the Atlantis Investment Facilitation to inform how they position the SEZ and in their promotion of green and smart development within the zone and broader Atlantis industrial area. The Economic Growth directorate, more broadly, will look to adapt Korean strategies for green economic development and industrial area development and revitalisation, to implementable strategies in the Cape Town context. The Policy and Strategy Department will utilize knowledge gained from the trip to, where relevant in the Cape Town context, inform key City strategies, including the Inclusive Economic Growth Strategy; IDP; MSDF and Waste Strategy.
- The KMAC and KOTRA researchers/delegation will be returning to Cape Town In September for the close out presentation of their research report for the City of Cape Town and the ASEZ. The CCT delegation were able to engage directly and at length with the KMAC team on the report while in Seoul, ensuring that the final report that will be presented in Cape Town will be accurate and of considerable use to both the ASEZ and the City.

- In the next phase of the project, the KOTRA and KMAC teams will assist in matchmaking between the City of Cape Town and Korean companies who may be looking to invest in Cape Town.
- The City is leveraging this visit to seek and conclude a City to City collaborative agreement with the City of Seoul. Initial investigation was undertaken to this end and we await feedback from Seoul.
- Explore the possibility of expanding any further knowledge sharing arrangements with various agencies such as the Smart City Integrated Center in the City of Anyang, The Korean Industrial Complex Corporation (KICOX) Managing Industrial Complexes, Guro Industrial Complex (Dedicated Labor - Intensive Light Industries), Incheon Free Economic Zone (IFEZ), Seoul Resource Recovery Facility (Waste to Energy), Magok Smart Industrial Complex (Understanding Industrial Clustering)
- Future topics for the City to consider through the KSP collaboration could be Smart Cities initiatives and Resource Recovery Facilities (how to manage waste, waste-to-energy processes etc)

sharing their approach and model. Anyang has entered various MOU agreements with other cities (eg Egypt.) This could be a path to explore where this tool could be duplicated in the Cape Town context over time and that strong policy support is crucial to be developed and could be incorporated in terms of our Precinct Plan initiatives that is driven by SPE as well as our future Property Development initiatives.

- ASEZ could be used as a test case to implement a Smart City model and should be explored. [Or even the greater Atlantis as a pilot]
- Another option is to look at the current system at the TMC in Goodwood and see if a collaboration with Anyang is of value to be explored to enhance the operation of the current system for greater impact.

Incheon Free Economic Zone (IFEZ), includes the 3 cities of Songo (global hub for the high tech knowledge service industry), Yeongeong (optimal location for logistics and tourism with world class airport facilities) and Cheonga (a new business town where business and residences co-exist). These cities has been developed in a relatively short period of time into a world-class international mega city, free Economic Zone.

The location to the Incheon airport is a main catalyst for this development.

Harbour project is planned be on 991ha, to be completed 2030 and will accommodate 29 berths for the pier and 6,19ha for the inland port.

Special investment benefits unique to the Incheon Free Economic Zone

- Tax reduction.
- Management Activities Support.
- Support for the Living Conditions of Foreigners.
- Regulation and burden relief.

- It was evident that a very detailed Masterplan exercise undertaken and the strategy to cluster the 3 cities in order to maximise synergies and strategic location has resulted in a successful development as is evident from the number of international organizations located here including the World Bank, the Green Climate Fund, and the Association of World Election Bodies. Further multinational companies from 15 countries have set up here including Samsung BioLogics, Celltrion, Boeing, BMW and GM.
- The main enabling factor for IFEZ seems to be the central support in terms of policy as well as funding together with the various incentives and de-regularisation that is offered to multinational investors to encourage ease of business and investment in the area. For ASEZ (and any other SEZ), it is essential that cooperation and collaboration is secured with both Provincial and

- Investor Immigration System.

National government as this would be crucial for the success any free economic zones. We would need to identify key stakeholders at each government sphere to create a working group that will assist the growth of ASEZ.

- The IFEZ development model fosters extensive economic growth by seeding investment in the form of base infrastructure, place making incentives for foreigner efforts, anchor investment. catalytic developments and international educational offerings. Infrastructure connections including major bridge and road upgrades enabled the physical linkage to the 3 cities. The upfront investment of infrastructure is a major catalyst for economic growth and foreign investment and City of Cape Town has done well to identify this and should continue to invest in targeted infrastructure development.
- City of Cape Town should investigate similar clustering concepts with neighbouring cities to potentially capitalise on the various unique offerings of the region. City of Cape Town is in a position to market these unique offerings as the Cape Town brand is well established internationally

Gyeonggi Banwol- Sihwa Smart Green Industrial Complex, has been established to upgrade the existing businesses and public facilities in the National Industrial Complex to make them digital, energy-independent and environmentally-friendly

 The clustering of the industrial sector in this complex allows for various opportunities and synergies relating to green technologies and management of resources.

Seoul Energy Dream Center,

- A strong learning was the innovative and interactive way that the initiative was showcased to market, educate and celebrate the initiative on how to utilise alternative energy
- It was good to see how a zero energy building operates and what is needed to achieve this status this is another area to explore if Cape Town (South Africa) would like to achieve Green Building

Status. The site visit was very informative for the ASEZ who play a role in the development of factories and have a strategic intent to have net zero carbon footprint.

City of Cape Town could replicate centres like this to showcase our initiatives to the public. This could be a very strong communication tool to the citizens (this was a clear standout learning throughout all the visits on how South Korea displays information to its citizens it increases transparency and accountability)

Magok Smart Industrial Complex Tour

- interesting that this lt development is driven by the Seoul City on commercial property basis and that land has been made available to private targeted institutions to encourage location and investment in the city to develop an area that was previously vacant and to foster economic growth for the city.
- The main enabling factor for this facility seems to be various incentives and de-regularisation that is offered to multinational investors to encourage ease of business and investment in the area. The current City of Cape Town SCM and land legislative environment disposal would make it difficult to duplicate this model and a SPV or SEZ would need to be established to allow for a commercial property market model to be established.
- Similarly the IFEZ, this development model fosters extensive economic growth targeting specific sectors, clustering these sectors, providing seeding investment in the form of base infrastructure, place making efforts, incentives for foreigner investment, catalytic anchor developments and international educational linkages (securing a highly educated labour resource for the high tech industries targeted in this development). Again the upfront investment of

	 infrastructure is a major catalyst for economic growth and foreign investment and City of Cape Town has done well to identify this and should continue to invest in targeted infrastructure development. The City and ASEZ should investigate their "snowball strategy" on how it is implemented and executed. Attracting large companies to attract smaller scale companies.
Seoul Resource Recovery Facility, utilising waste into energy for households	 It will be good to link the City's Solid Waste department with this facility The Seoul Resource Recovery facility incinerates general waste, capturing the thermal energy created and returning that to the grid, the remaining waste, of which there is little, is transferred to the landfill. This process performs a dual purpose of generating energy and minimizing the need for landfill space, both highly pertinent issues in the Cape Town context where energy insecurity persists and landfill space is reaching its capacity. The City's Solid Waste Department could engage further on how the recovery facility was implemented and garner some insights on their model to see how it could work
KICOX - Korea Industrial Complex Corporation	within a Cape Town concept. • Key learning there for me was: The integrated approach to the management of +/-26 industrial areas can yield important lessons for the City of Cape Town. Currently our industrial areas tend to be managed independently of each other and from a place-based and town planning perspective. The KICOX model, however, provides an overall strategic intent and ensures that complementarities between areas are maximized. The City should consider undertaking an industrial zone revitalization strategy which draws directly on the KICOX experience.

 - Follow up with the KMAC researchers to obtain the soft copy of the interim report that was presented on the 17th of July 2024
 - Circulate the draft interim report to key City stakeholders and ASEZ colleagues for comments
 - Consolidate the comments and return to the KMAC researchers to assist with finalising the report
 - Meet with staff that attended the trip to provide potential dates as suggestions in September for the close out report engagement.
 - When dates are confirmed, we would need to send to KOTRA and KMAC for further arrangements.
- Follow up with KOTRA and KMAC to obtain all the presentations that was presented at each engagement
- Liaise further for assistance to link in with the project manager from the IFEZ to meet with the ASEZ (online) for further engagement regarding operations and management of the IFEZ.
- Liaise further to set up an engagement (online) assisted via the KMAC with the Saemangeum Economic Zone

9. GENERAL DISCUSSION

The recent visit to South Korea by representatives from various City of Cape Town departments and ASEZ was a strategically significant endeavour designed to enhance the City's approach to economic development, particularly within the Atlantis Special Economic Zone (ASEZ). This trip, which took place between July 13th and 20th, 2024, was part of the broader Knowledge Sharing Programme (KSP) spearheaded by the Korea Management Association Consulting (KMAC) and the Korea Trade-Investment Promotion Agency (KOTRA).

Objectives and Strategic Value of the Trip

Capacity Building and Training: The primary objective of the trip was to participate in the capacity building and training programme hosted by KMAC and KOTRA. This programme represents the third phase of the KSP and aims to equip Cape Town officials with the knowledge and skills necessary to enhance investment conditions, transition towards carbon neutrality, and foster green industries within ASEZ. The hands-on experience in South Korea was pivotal for understanding how the country's policies and strategies can be adapted to the Cape Town context.

Learning and Implementation: The delegation gained valuable insights from a variety of site visits and meetings with economic development practitioners, companies, and municipal entities. These experiences provided a clearer understanding of how South Korea's successful strategies in special economic zones (SEZs) and green economic development can be applied to Cape Town. Specific areas of learning include green and smart development practices, industrial area revitalization, and effective strategies for waste management and energy recovery.

Value-Adds to Cape Town and ASEZ

- 1. **Enhanced Strategies for ASEZ:** The knowledge obtained from the South Korean visit will directly influence how ASEZ positions itself and promotes green and smart development within its zone. This involves integrating best practices from South Korea into ASEZ's strategic planning and implementation processes, particularly in the areas of green economic development and industrial area revitalization.
- 2. Informed City Strategies: The Economic Growth Directorate and Policy and Strategy Department will adapt Korean strategies to inform key City strategies, including the Inclusive Economic Growth Strategy, Integrated Development Plan (IDP), Municipal Spatial Development Framework (MSDF), and Waste Strategy. This will ensure that the City's plans are aligned with best practices in economic development and environmental sustainability.
- 3. **Research and Partnership Development:** The upcoming return of the KMAC and KOTRA teams in September for the close-out presentation of their research report will provide further detailed insights. This presentation will be crucial for ensuring that the final report is comprehensive and actionable. Additionally, the trip has laid the groundwork for potential partnerships with Korean companies interested in investing in Cape Town.
- 4. **City-to-City Collaboration:** Initial discussions have begun on establishing a collaborative agreement between Cape Town and Seoul. This agreement could facilitate deeper bilateral cooperation in areas such as economic development, technology exchange, and cultural exchange.
- 5. Expanding Knowledge Sharing: The trip opened avenues for further knowledge sharing with Korean agencies such as the Smart City Integrated Center in Anyang, the Korean Industrial Complex Corporation (KICOX), and the Incheon Free Economic Zone (IFEZ). These agencies offer expertise in various fields, including smart city initiatives, industrial complex management, and resource recovery.
- 6. **Future Collaboration Topics:** Future collaboration through the KSP could focus on topics such as Smart City initiatives and Resource Recovery Facilities. Exploring these areas could lead to innovative solutions for managing waste and optimizing energy recovery processes in Cape Town.

Background of the Knowledge Sharing Programme (KSP)

The KSP is a structured initiative designed to facilitate the exchange of knowledge and best practices between South Korea and participating cities. For Cape Town, the KSP aims to enhance the City's economic and environmental strategies by leveraging South Korea's experience in developing successful SEZs and green industries. The trip to South Korea provided the City's key participants, including the Economic Growth Directorate and the Atlantis Special Economic Zone, with the opportunity to witness and learn from the implementation of policies that have led to South Korea's success in these areas.

In summary, the South Korean visit was instrumental in deepening Cape Town's understanding of effective economic and environmental strategies. The insights gained will be instrumental in shaping the future of ASEZ and broader City initiatives, promoting sustainable development, and fostering international partnerships.
