PROVIDE SUMMARY OF HOST ORGANISATION / CITY

Fostering (Cross-Border) City-City Collaboration to Prevent Hate, Extremism and Polarisation in border areas in Tanzania, as well as how local, national and international actors are addressing such challenges. Dedicated to building a foundation for long-term collaboration between Cape Town, Mombasa, and Zanzibar as part of the Hub's broader technical assistance Programme for Zanzibar.

4. OBJECTIVE

To share how they work with young people as both partners and beneficiaries of prevention programming. Providing practical guidance was the focus to support the implementation and institutionalization of such practices in Zanzibar. Dedicated to building a foundation for long-term collaboration between Cape Town, Mombasa, and Zanzibar as part of the hub's broader technical assistance programme for Zanzibar.

5. OUTCOMES

The City of Cape Town has implemented several multi-actor practices to prevent gangsterisme, particularly amongst young people, lessons from which can be transfer to preventing youth from engaging in hate and extremism. Among the youth engagement practices, this session included the School Resource Officers model, Junior City Council, youth volunteerism (Cadet Programme) and Neighbourhood Watch. For strengthening cross-border city-city collaboration (e.g., between Mombasa, Zanzibar and with support from Cape Town). International good practices and provide a platform through which to share their innovative approaches and experiences with other cities around the world.

6. ACTIONS REQUIRED

Further engagement will build on shared lessons learned, providing ongoing guidance on best practices. Stronger Cities Network will monitor the need for further engagement and coordinate further sharing.
