Resilient Cities (R-Cities) Network is a network which is dedicated to advancing the urban resilience agenda and advocating for solutions and resilient finance in order that cities can thrive in the face of multiple urban challenges – especially in light of climate change.

The City of Cape Town has been an active member of the network since 2017 and maintains strong relationships through its Chief Resilience Officer.

4. OBJECTIVE

The Resilient Cities Network invited the Chief Resilience Officer (CRO) Daniel Sullivan to join them at the New York Climate Week for the convening of key R-Cities network sessions. Further, the New York Climate, which occurred in New York at the same time, offered a unique opportunity for cities like Cape Town to showcase engage with panels around resilient finance, climate and health, and climate change response and action more broadly.

5. OUTCOMES

- Engaged with risk and technology professionals on tools to evaluate the cost of building in climate risk resilience into project design at a conference organised by Howden and Microsoft.
