		2.1 The facility is used for an event which Council has initiated, supports or participates in.								
		2.2 The application has been received at least 14 (fourteen) days before the intended use of the facility.								
		2.3 Such person or institution first obtains approval in writing from the relevant Council Director that they satisfy the requirements of paragraph 2.1. The relevant Director shall assess this against approved criteria.
