1. The relevant Local Authority must be notified of any disease scheduled in terms of Section 45 of the Health Act of 1977 (Act 63 of 1977) on the GW17/5 form.
2. In addition to the passive GW17/5 notification system, an active surveillance system is also in place for priority EPI diseases such as Measles, Acute Flaccid Paralysis (AFP) / Polio, Neonatal Tetanus (NNT).
3. All GW17/5 notifications must be channeled through the respective Local Authority, to the respective Regional Office for the necessary processing before submission to the Provincial Directorate of Health Information Management Systems.
