Illegal dumpers beware:

There are serious consequences for those who are caught dumping. Admission of guilt fines range from R500 – R5 000. In extreme cases the matter will go to court where the potential penalty can increase to over R10 000, or include imprisonment.

Vehicles involved in illegal dumping can also be impounded.

The impoundment release fee for a first offence is R8 700. Should the same vehicle be impounded a second time, the release fee is R11 700, and it will be R17 400 for a third offence.
